## ARTICLE 1: OBJECT

An internal regulation is established governing the operation of the International Comic Strip Festival in Tunisia in Sousse.

This regulation specifies in particular the conditions of entry and exit of the festival, bulky or forbidden objects, etc ...

## ARTICLE 2: DESCRIPTION

The International Comic Strip Festival in Tunisia will be held from 20 to 23 MARCH 2019 in Sousse.

Thus, several thematic areas will form the territory of the event following the program concretized and validated, a concert-theater-show, an artistic "city", as well as a set of infrastructures hosting points of sale and catering.

The thematic areas of the International Comics Festival in Tunisia in Sousse will be from 10:00 to 18:30

#### ARTICLE 3: ENTRY AND EXIT OF THE FESTIVAL

Entry into the festival grounds is via ticket control and security control.

A line reserved for e-ticket holders is set up for a more fluid access.

Tickets are non-exchangeable and non-refundable. We remind you that tickets purchased on unofficial sites do not guarantee you access to the festival. Holders of a 4-day Pass must present it to each thematic area and a piece of identification, if the security service feels the need for it to be presented.

Student, high school, college and student passes are obtained on presentation of a proof of age, and on justifying evidence presented by teachers / supervisors.

ALL OUTPUT IS DEFINITIVE

#### ARTICLE 4: GENERAL CONDITIONS OF ACCESS

Access to validated thematic areas is only allowed to persons with a Pass or invitation issued by the U.F.E. SOUSSE, co-founding organizer of the International Comic Strip Festival in Tunisia in Sousse.

4.1 - Anyone entering the thematic areas of the International Comics Festival in Tunisia in Sousse must comply with these rules of procedure.

4.2 - Anyone who enters the festival accepts the risk of being confronted by a large crowd. Thus, every participant declares himself in a good state of physical and moral health.

4.3 - Access to the festival is allowed under the condition that they are supervised by the pedagogical managers. For students with the current student card of the current year 2018-2019.

Only students coming alone from 18 years old are allowed to access the festival. For children under 18, they must be accompanied by their parents.

4.4 - Access to the event is strictly forbidden to festival-goers accompanied by our friends the animals and animals.

4.5 - Any person present as part of an intervention on the current event (staff, technicians, artists, journalists, production staff, service providers, etc ...) must be provided with a

identification badge visible. These badges are only issued by the U.F.E. Sousse. An ID may be requested at the entrance of the festival.

4.6 - It is forbidden to enter the festival with food and drinks of any kind. Thus, only the drinks and food put up for sale by the co-founder U.F.E. SOUSSE and Festival partners are allowed in the festival area. Any breach of these rules may result in the immediate and final expulsion of the festival. An exception will be made for the Festival's Steering Committee, for the special guests who will spend the day at the Festival throughout its duration.

4.7 - Access to the festival will be refused to anyone in a state of intoxication or under the influence of drugs.

4.8 - The organizer U.F.E. SOUSSE, as well as the security services in place, reserve the right to refuse access to the festival to any person. This access ban will not have to be motivated.

4.9 - For the smooth running of the event, each person inside the festival grounds must be able to present to the organizer U.F.E. SOUSSE or a person assigned to the security service, on request, his valid Pass. Any offender can be immediately excluded from the site by simple decision of the organization, without being able to justify any possible recourse or claim any refund.

4.10 - The U.F.E. SOUSSE reserves the right to close public access once the spectator gauge is reached on the festival site or for any other reason of security or public order.

#### ARTICLE 5: PRESS ACCESS

For the press, it is necessary to obtain a press accreditation.

#### ARTICLE 6: ACCESS TO REDUCTIONS OF ACTIVITIES AND ADDITIONAL SERVICES

On presentation of the Pass International Comics Festival in Tunisia in Sousse, valid for the current day, or Pass valid for 4 days, festival-goers can benefit from a reduction on the services of our partners, including hotel, catering, consumption , etc ....

#### ARTICLE 7: OBJECTS COMPULSORY AND PROHIBITED

7.1 - Access to the festival is not allowed to people carrying bulky objects. It is also forbidden to introduce any object that can be used as a projectile and that may be dangerous for festival-goers, artists or the staff assigned to the organization of the festival, including:

- Weapons and ammunition of any category, tear gas or any sharp object
- Explosive, flammable or volatile substances, especially aerosols
- Alcoholic Beverages and Illicit Substances
- Glass, plastic or any other bottles, empty or full
- Rolling objects, motorized or not (roller, scooter, bikes, motorcycles, scooters, etc ...) excluding wheelchairs or strollers
- Bags and backpacks with a capacity greater than ten liters
- Road safety helmets
- Music headphones, musical instruments (with or without cover)
- Other objects of the type glue, etc ...

7.2 - These items will be automatically confiscated and thrown away by security personnel at the entrance of the festival. As for the products prohibited by the Tunisian legislation, they will be given to the competent authorities. Anyone refusing access to the event without a cumbersome or prohibited object will be denied access to the festival.

7.3 - No deposit will be taken on the site of the theme areas of the Festival.

During his visit to the festival, the person will be fully responsible for the bulky or forbidden item, and will be left with it or have it guarded by a third party at the entrance.

#### ARTICLE 8: CONTROL AND SAFETY

8.1 - For reasons of security of persons and property, security personnel may ask festival-goers and any other person wishing to access the festival or who are already present on the Festival grounds, to open their bags and check their content. Indeed, to ensure optimal security, the verification of the contents of the bags will be systematic and mandatory.

8.2 - In the paramount objective of ensuring security, each individual wishing to access the thematic areas of the International Comic Strip Festival in Tunisia in Sousse must comply with a necessary palpation.

8.3 - Each festival-goer undertakes to respect any directive of the authorized staff or its agents who can justify their accreditation.

#### ARTICLE 9: FESTIVAL OBLIGATIONS AND RESPECT FOR STAFF

9.1 - Festival-goers are requested to refrain from any aggressive or insulting behavior and from any attitude or dress that is contrary to morality, which may inconvenience other festival-goers, artists and staff.

9.2 - A costumed visitor, whose costume is considered too indecent, may be asked to wear a more appropriate attire to attend a public place. Only the organizers are entitled to judge the decency of an outfit.

9.3 - To preserve the quality of the festival's facilities, it is forbidden to affix inscriptions or posters on any place, furniture or building, and to throw rubbish and butts on the ground. For this purpose, bins will be made available. Festival-goers are asked to respect the place. Any use of the electrical network, installed for the occasion, is prohibited for anyone other than the duly authorized personnel. The goal is to leave the site as it was when they arrived in the Festival's thematic areas.

9.4 - Finally, the organizers reserve the right to call to order or to definitively exclude any person who does not respect these stipulations.

9.5 - At the end of the Festival or after the final exit of the event, festival-goers are asked not to disturb the tranquility of the neighborhood, especially through noise pollution.

#### ARTICLE 10: NEUTRALITY

10.1 - It is forbidden to engage in religious, political or ideological acts, distribution of leaflets of any kind, quests, subscriptions or signature collections, etc ...

Exception will be made through a partnership signed with the organizer of the Festival U.F.E. SOUSSE, following decision taken upstream by the Bureau of the Association.

10.2 - Similarly, all documents, leaflets, badges, symbols or banners of a political, religious, trade union, racist or xenophobic nature are strictly forbidden.

10.3 - The U.F.E. SOUSSE is a Tunisian association, apolitical, respecting and applying the decree-law N ° 2011-88 of September 22, 2011.

#### ARTICLE 11: DAMAGES

Entry into the festival is at your own risk. The organizer of the Festival, U.F.E. SOUSSE disclaims all liability for damages that may arise directly or indirectly from acts or omissions of the Festival Organization, the organizing staff, or any person who has been hired for the Festival, or a third party, during the time within the Festival's thematic areas.

#### ARTICLE 12: SURVEY, SURVEY AND DISTRIBUTION OF TRACTS

Opinion polls and interviews are forbidden within the scope of the Festival's thematic areas, except with the express prior written permission of the organizer U.F.E. Sousse. Any promotion, distribution of leaflets, leaflets or samples within or in the immediate vicinity of the said perimeter, which is not carried out by the organization or expressly authorized by it in writing, is prohibited, and security may be confiscated the object of the offense.

#### ARTICLE 13: FOOD AND DRINKS

The sale of beverages and foodstuffs within the Festival is prohibited to anyone who has not been duly authorized by the U.F.E. Sousse. Any drink sold on the site will be delivered open (without cap) or decapped in front of the customer.

#### ARTICLE 14: MEANS OF PAYMENT

A central cash register will be placed at the main entrance of the International Comics Festival in Tunisia in Sousse and held by a person authorized and mandated by the Steering Committee of the U.F.E. Organizing Association. Sousse.

The central fund will be open from 09:00 to 17:30 (one hour before the closing of the Festival).

#### ARTICLE 15: SMOKING AND STUFFING

15.1 - Smoking is only allowed in the catering areas provided for this purpose.

Outside these areas, smoking is prohibited in all thematic areas.

15.2 - It is strictly forbidden to detain and use narcotics inside or around the perimeter of the event, under penalty of final expulsion, for any general public or staff or team or participants.

#### ARTICLE 16: CONDUCT TO BE TAKEN IN CASE OF MALAYSIA OR ACCIDENT

16.1 - A Croissant Rouge stand is set up and signposted on the Festival site.

16.2 - Festival-goers are asked to report to security personnel any accident or discomfort occurring on a person.

#### ARTICLE 17: CONDUCT TO BE TAKEN IN CASE OF EVACUATION

17.1 - In the event of a major incident endangering the safety of the festival-goers and the personnel located in the perimeter of the event, such as the meteorological risk, an important technical problem, in fire or a bomb alert, the evacuation said perimeter will be triggered by an order placed by the UFE Steering Committee Festival Commissioner SOUSSE transmitted to security.

17.2 - In order for the evacuation to be carried out in the best conditions of safety and time, the persons present will immediately and calmly have to turn towards the emergency exits provided for this purpose to be guided outwards by the security personnel .

17.3 - The event will be canceled only if the mandatory security conditions are not met.

17.4 - The U.F.E. SOUSSE reserves the right to cancel the Festival, purely and simply in case of major problem, beyond its control.

#### ARTICLE 18: REIMBURSEMENT OF TICKETS

Festival-goers will be reimbursed for their Pass, excluding registration fees, only in the event of a cancellation of the Festival in case of force majeure, and this BEFORE the opening date of the Festival.

In the case of a 4-day Pass, and if the Festival is closed one day, the refund will only concern the canceled date.

The refund period may take up to 3 months after the Festival and the date canceled.

Apart from this condition of force majeure, no ticket purchased for the Festival will be refundable.

## ARTICLE 19: FOUND OBJECTS

Any object found will be given to the police (main office) of Sousse or to the City of Sousse, lost property service.

## ARTICLE 20: FLIGHTS OF PERSONAL EFFECTS

20.1 - In case of theft of personal belongings, the U.F.E. SOUSSE can not under any circumstances be held responsible. It is therefore appropriate for each festival-goer to be vigilant.

20.2 - The U.F.E. SOUSSE declines all responsibility for loss or theft.

## ARTICLE 21: INDUSTRIAL PROPERTY AND IMAGE RIGHTS

21.1 - In order to guarantee the right to the image and the right of intellectual and artistic property, it is prohibited to take photographs or to make visual and / or sound recordings, whatever they are and share any means except for journalists duly accredited by the UFE Organizing Association Sousse. Indeed, it is expressly stated that the authorization to film or photograph is entrusted to persons nominally identified for precisely delimited subjects. Thus, the U.F.E. SOUSSE reserves the right to deny access to any person who has been authorized to photograph or film the event for a reporting subject that is not the one he is actually pursuing.

21.2 - By accessing the thematic areas of the Festival, any festival-goer agrees to be photographed or filmed in the audience of the festival-goers. These images and videos are intended for the internal use of U.F.E. Sousse. However, they can be used to illustrate articles in the press, on the internet, on television, on the site or facebook, on a promotional leaflet, etc ... In any case, the festival-goers will be able to claim any rights or compensations they are recognized on photographs or videos of the festival, whatever the medium of diffusion in question.

## ARTICLE 22: SANCTIONS

Any infringement of these rules exposes the offender to the immediate exclusion of the event and, if necessary, to legal proceedings. Any attempt or performance of theft, destruction, deterioration or deterioration of a movable or immovable object found on or near the festival's thematic areas is punishable by criminal penalties. In general, the U.F.E. SOUSSE may proceed to the exclusion of any person for non-compliance with these rules of procedure or the national legislation in force.
